classifications, related privileges, and applicable dues are determined by the Director or the Director's designee. The membership classifications, which depend on the number of adults and children allowed admission to the Garden, types of privileges and corresponding dues, include: Individual; Dual; Family; Grandparents; Family and Friends; Sustaining; Signature; Fellow; Silver Fellow; Gold Fellow; Platinum Fellow and Life Member.

Form 990, Part VI, Line 7a - Election of Members and Their Rights

At every meeting of members, each member in good standing is entitled to vote in person, or by proxy, on the matters noticed for the meeting. Such matters may include election of members of the governing body or issues other than election of members of the governing body. Procedures for obtaining and using proxies are provided in the By-Laws. Each Member of the Corporation is entitled to one (1) vote. All elections and all issues are decided by a majority vote of the persons present in person or by proxy.

After any changes are made based on the process described above, the CFO provides a copy of the draft of the Form 990 to the members of the Board of Trustees of the organization for their review and comments prior to filing. After any changes are made based on the review by the Board of Trustees, the Form 990 is then finalized and signed by the Treasurer of the Board of Trustees or the CFO.
