Recognized by the American Public Garden Association as a collection of national significance, Fairchild curates & displays the world's greatest collection of palms in any botanic garden. Our palm collection is the world's largest in public display, & is an invaluable resource for horticulturalists, researchers & conservationists worldwide.

Current research and conservation projects include studies of tropical fruit crop diversity, the evolution and classification of palms, restoration of South Florida and Caribbean ecosystems, the ecology of tropical forests in a changing climate, the evolution of plants on tropical islands, and the interactions among birds, insects, and tropical plants. All of these projects have a high level of community engagement, including university faculty, K-12 and university students, and volunteers.

The Garden itself is an 83-acre living laboratory with rich representation of the global tropical flora. Our living plant collection is a source of material for genetic, chemical, anatomical, morphological, horticultural, and physiological research. These programs are the result of cooperative efforts, led by seasoned educators on staff and involving input from program volunteers, teachers, students, science and curriculum specialists, research and horticulture staff and dedicated community partnerships.

Fairchild's award winning, interdisciplinary, environmental science competition, The Fairchild Challenge, is designed to engage students of diverse interests, abilities, talents, and backgrounds to explore the natural world. Reaching over 125,000 students annually, the program has been recognized as a benchmark for exceptional STEM education and for empowering PreK-12th grade students to become the next generation of scientists, researchers, educated voters, policy makers, and environmentally-minded citizens. The Fairchild Challenge has become a model beyond South Florida, influencing programs nationally and internationally. In partnership with NASA, we are providing South Florida middle and high school students an opportunity to conduct authentic botanical research in the classroom. Together, we are administering plant experiments with over 130 classrooms participating in The Fairchild Challenge, to determine which edible plants might be suitable for growth in microgravity aboard the International Space Station's plant growth facility. The purpose of the experiments is to expand food options and increase plant diversity by testing multiple edible plants that meet NASA's criteria for size and edibility. Using equipment that mimics the environmental conditions aboard the International Space Station, students are testing factors that may influence plant growth, flavor, and nutrition. NASA will use students' data to determine which plants they should begin

growing in space.

The Fairchild Explorer and Discovery programs engage more than 7,200 students from over 280 schools. The programs immerse young people in hand-on activities as they experience the science and beauty of Fairchild. The "Lifelong Learning Program" offers more than 2,000 participants, attending more than 200 classes, the opportunity to experience new and diverse concepts about the beauty and value of nature.

Fairchild is also a leading regional cultural institution and favorite visitor destination for both tourists and local residents. Our festivals, such as the International Mango Festival, the International Orchid Festival, and the International Chocolate Festival, are more than just spectacular events; they also have an education component with local and global experts giving lectures, talks and classes. During FY15-16, there were more than 190,000 visitors to the Garden and close to 1,400 dedicated, energetic and talented volunteers supported Fairchild's programs by donating more the 70,000 hours of their time. Fairchild's state-of-the-art DiMare Science Village and Hsiao Tropical Plant Laboratories continue to serve as a meeting place for many students, scholars and dignitaries. McQuillan Arts Center served as the exhibition center for the works of Clyde Butcher and Mira Lehr during the FY15-16 art season, part of the annual Art at Fairchild exhibitions held in the Garden since 2005. Clyde Butcher presented his "Preserving Eden" exhibit consisting of 32 black and white photographs capturing Florida's natural landscapes and Mira Lehr presented her "Second Nature" multimedia exhibition using non-traditional materials. Recent exhibits have included world renowned glass artist Dale Chihuly and other influential artists such as Fernando Botero, Roy Lichtenstein, Mark di Suvero, Yayoi Kusama, Francois-Xavier and Claude Lalanne, Yoko Ono's Wishing Grove, the art of Will Ryman's oversized, brightly colored roses and Chapungu: Custom and Legend, a Culture in Stone. Three sculptures by Dale Chihuly and one from Daisy Youngblood are permanently installed at Fairchild.
